**ARTICLES OF INCORPORATION
OF
BCC SUB, INC.**

The undersigned Incorporator subscribing to these Articles of Incorporation, being competent to contract, hereby forms a Corporation under the provisions of Chapter 607 of the Florida Statutes, and for these purposes they adopt the following Articles of Incorporation.

**ARTICLE I
CORPORATE NAME AND DURATION**

1. The name of the corporation shall be BCC Sub, Inc., by which name it may sue and be sued, contract and be contracted with, and employ a corporate seal. BCC Sub, Inc. may hereinafter be referred to as the "Corporation."

2. The corporate existence of this Corporation shall begin on the date the certificate of incorporation is issued by the Secretary of State of Florida and shall continue perpetually thereafter unless dissolved as provided by law.

3. The principal office and place of business of the corporation shall be located at 4646 9th Ave W, Bradenton, FL 34209, although the corporation may maintain offices elsewhere.

**ARTICLE II
PURPOSE**

The purpose of this Corporation is to engage in any and all business not prohibited by the Laws of the State of Florida. This Corporation shall have all powers given corporations under the Laws of the State of Florida.




