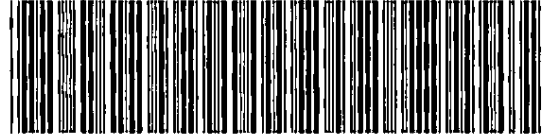

1. Introduction. Joseph Hopcroft, being duly sworn, deposes and says:


