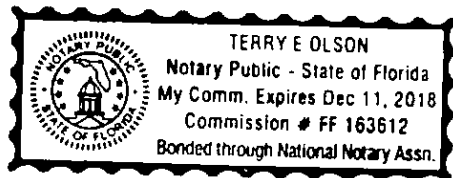
1. Introduction. David L Baumgardner, being duly sworn, deposes and says:
