**ARTICLES OF INCORPORATION
OF

Article I - Name

The name of this corporation is ROCKY MOUNTAIN SCHOOL OF ART II, INC.

Article II - Principal Office and Mailing Address

The street address of the principal office and the mailing address of the corporation shall be 3300 University Boulevard, Suite 218, Winter Park, FL 32792.

Article III - Business Purpose

The nature of the corporation's business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act, Chapter 607, *Florida Statutes*.


