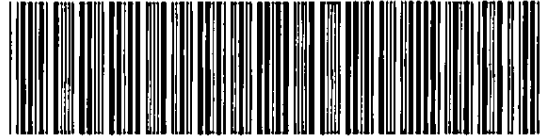

FOURTH: Article VI is corrected as follows:


