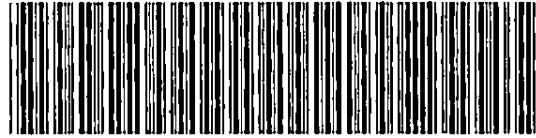

**ARTICLES OF INCORPORATION**  
**OF**

The undersigned incorporator, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following articles of incorporation.

**ARTICLE I. CORPORATE NAME**

The name of this corporation is **SUN N SOLAR WORLD CLASS SERVICES, INC.**

**ARTICLE II. EXISTENCE**

The corporation's existence shall begin on 17 October 2018.

**ARTICLE III. PRINCIPAL OFFICE**

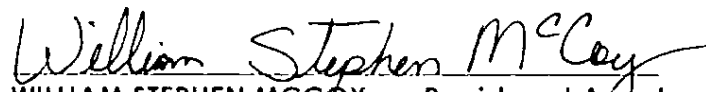
