## ARTICLES OF INCORPORATION

### HEF-POINCIANA CROSSING, INC.

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

**FIRST:** The corporate name of the corporation (hereinafter called the "Corporation") is HEF-POINCIANA CROSSING, INC.

**SECOND:** The street address and mailing address of the principal office of the corporation is 437 SW 4<sup>th</sup> Avenue, Ft. Lauderdale, FL 33315.

**THIRD:** The number of shares that the Corporation is authorized to issue is 10 shares of Common Stock, no par value.


**SIXTH:** The purpose for which the Corporation is organized is as follows:
