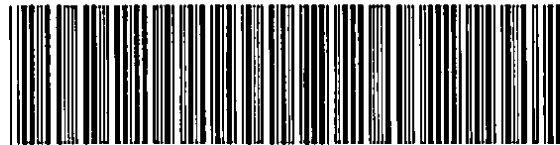


#### ARTICLE XI




