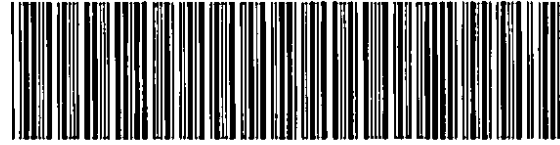





The meeting was called to order and proceeded with the business of the meeting.


It was resolved by unanimous vote that:

2. Permission and Consent is given to Sophia Greiner to use the name ADVANCED COUNSELING SERVICES, PA in forming a new for-profit corporation.


There being no further business, the meeting was adjourned at 10:10 a.m. The written consent is signed on October 4, 2018.
