ARTICLE I

NAME

The name of this corporation is:

ARTICLE II

DURATION

This corporation is to exist perpetually. It shall commence it is existence upon the filling of these Articles of Incorporation.

ARTICLE BI

PURPOSE

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE IV

CAPITAL TO BEGIN BUSINESS

This corporation is authorized to issue one hundred (100) shares at filive dollars (\$5.00) dollars par value.

ARTICLE IX

INDEMNIFICATION
