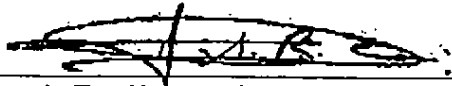

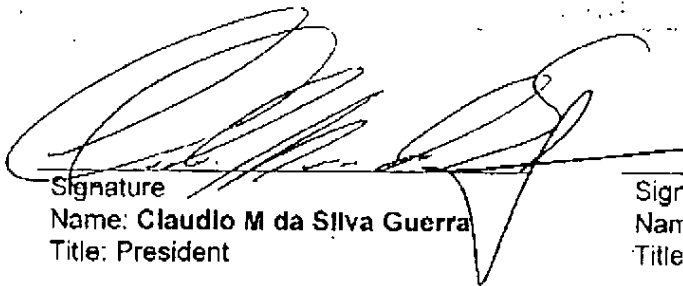

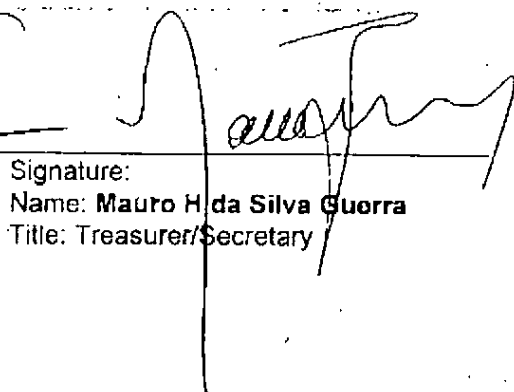
Second: The date of adoption of the amendments.
