ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1006, Florida Statutes, this FLORIDA PROFIT CORPORATION adopts the following amendments to its Articles of Incorporation on May 31, 2023.

ARTICLE IV

The total number of shares of stock the Corporation is authorized to issue is 1,000 shares.

- 1. <u>Authorized Shares</u>. The Corporation is authorized to issue 1,000 shares of common stock, of which (i) 500 shares shall consist of voting shares and shall be designated as "Series A Shares;" and (ii) 500 shares shall consist of non-voting shares and shall be designated as "Series B Shares." The designation, powers, preferences and relative participation and other rights and the qualifications, limitation and restrictions thereof in respect to each class of capital stock of the Corporation are as set forth below in this Article IV.
- 2. <u>Series A Shares</u>. Each holder of record of Series A Shares shall have full voting rights and shall be entitled to one (1) vote per share, shall be entitled to notice of any shareholders' meeting in accordance with the Bylaws of the Corporation, and shall be entitled to vote upon such matters and in such as a manner as provided in the Bylaws of this Corporation or otherwise as provided by law.
- 3. <u>Series B Shares</u>. Each holder of record of Series B Shares shall not have any voting rights except as required by law.
- 4. <u>Dividends</u>. The holders of Series A Shares and Series B Shares shall be entitled to receive such dividends as may be declared from time to time by the Board of Directors of the Corporation, proportionately based upon the number of issued and outstanding common shares of the Corporation. If dividends are paid in shares of common stock, the common stock distributed to the holders of Series A Shares shall be in the form of Series A Shares, and the stock distributed to the holders of Series B Shares shall be in the form of Series B Shares.
- 5. <u>Liquidation Rights</u>. Upon the liquidation, dissolution or winding up of the Corporation, the assets of the Corporation shall be distributed to the holders of the Series A Shares and the Series B Shares proportionately based upon the number of issued and outstanding common shares of the Corporation, but only the Series A Shares shall have voting rights.
