On March 19, 2019, I started receiving information from credit card companies and LifeLock Services that someone was attempting to use my personal identity information/SS#, Name, and Address to fraudulently obtain or change existing account information. I do have an account freeze with Equifax, TransUnion and Experian.

On March 20, 2019 I received a letter from Citi AAdvantage Business card asking for additional information for an application that they had received from "me" using my personal information. Through investigation on my part I found that the above company has me listed as Secretary of the company with my residence address. Prior to this I had no knowledge or participation of/with this company and I certainly have not authorized nor consented to the use of my name, address or any personal or business information.

The information on the annual report was filed without my knowledge, authorization or consent. Further, I consider the inclusion that I am the secretary is false and fraudulent and entirely misleading.

I have met with and provided the Temple Terrace, Florida Police Department all information pertaining to this matter and the identity theft itself.

I also wish to mention that I consider this to be Exploitation of the Elderly. In my investigation of this matter on me, I also found that the person listed as the Asst. Secretary is in her seventies. I am hoping that law enforcement will consider this as well.
