

The undersigned, for the purpose of forming a professional service corporation, for profit, files these Articles of Incorporation with the Secretary of State of the State of Florida, pursuant to the Professional Service Corporation and Limited Liability Company Act of the State of Florida, Chapter 621, Florida Statutes.

- 1. Name. The name of the corporation is Kevin Segall, DC, P.A. (the "Corporation").
- 2. <u>Nature of Business:</u> The nature of business to be transacted by the Corporation is to engage in the practice of chiropractic medicine.
