The undersigned, for the purpose of forming a professional service corporation, for profit, files these Articles of Incorporation with the Secretary of State of the State of Florida, pursuant to the Professional Service Corporation and Limited Liability Company Act of the State of Florida, Chapter 621, Florida Statutes.

1. Name. The name of the corporation is Kevin Segall, DC, P.A. (the "Corporation").
2. Nature of Business. The nature of business to be transacted by the Corporation is to engage in the practice of chiropractic medicine.
3. Address. The street address and the mailing address of the initial principal office of the Corporation is 2090 Dr. Martin Luther King Street North, St. Petersburg, Florida 33704.
4. Number of Shares. The number of shares which the Corporation is authorized to issue is 7,500 shares of common stock, having a par value of \$1.00 per share.
5. No Preemptive Rights. No preemptive rights are granted to shareholders of the Corporation.
6. Effective Date. These Articles of Incorporation shall be effective upon filing with the Florida Department of State, Division of Corporations.

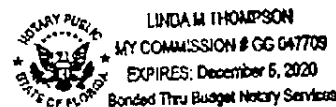
