**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of Bootleg Advisors, Inc., under the Florida Business Corporation Act, Florida Statutes Chapter 607, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME



The undersigned Incorporator, for the purpose of forming a corporation under the laws of the State of Florida, has executed these Articles of Incorporation on November 21, 2018.




