**ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of the corporation is BUILD INVESTMENTS CORP. (the "Corporation").

ARTICLE II. ADDRESS

The initial principal place of business of the Corporation is:

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the Corporation will commence on January 1, 2019.

ARTICLE IV. PURPOSE

ARTICLE V. AUTHORIZED SHARES

The rights, preferences, and privileges of the Class A Shares and the Class B Shares shall be identical, except that the Class A Shares will not be entitled to vote on any matter required to be approved by, or submitted for approval of, the shareholders.

ARTICLE VIII. INITIAL BOARD OF DIRECTORS

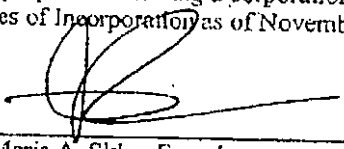
