ARTICLES OF AMENDMENT TO SECOND AMENDED AND RESTATED ARTICLES OF INCORPORATION OF INHEALTH, INC.

Pursuant to provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation hereby submits these Articles of Amendment (the "Articles of Amendment") for the purpose of amending its Second Amended and Restated Articles of Incorporation (the "Articles of Incorporation").

1. The name of the corporation is INHealth, Inc. (the "Corporation").

2. The Articles of Incorporation are hereby amended by deleting the first sentence of <u>Article V: Authorized Shares</u>, in its entirety to read as follows:

"The total number of shares of all classes of stock that the Corporation has authority to issue is Two Million Five Hundred Seventy-Three Thousand Seven Hundred Fifty (2,573,750) consisting of (a) Two Million One Hundred Thousand (2,100,000) shares of Common Stock, \$0.0001 par value per share (the "Common Stock"), and (b) Four Hundred Seventy-Three Thousand Seven Hundred Fifty (473,750) shares of Preferred Stock (as defined below), \$0.0001 par value per share.

3. These Articles of Amendment to the Articles of Incorporation were approved by the shareholders of the Corporation on March 18, 2022.

4. These Articles of Amendment to the Articles of Incorporation will be effective upon filing.
