*Articles of Amendment to
Articles of Incorporation
of
ART REMODELING & CONSTRUCTION CORP.*

In accordance with the provisions of Florida Statutes Section 607.1006, the sole Director of **ART REMODELING & CONSTRUCTION CORP.**, a Florida corporation, incorporated on December 3, 2018 (the "Corporation"), hereby amends the Articles of Incorporation of the Corporation as follows:

1. The text of the amendment is as follows:

Article IV of the existing Articles of Incorporation of the Corporation, which relates to the number and classes of shares the Corporation is authorized to issue, is hereby deleted in its entirety and the following new Article IV shall be inserted in lieu thereof:

ARTICLE IV

The total number of shares which the Corporation is authorized to issue is 1,000, shares of common stock consisting of two classes of shares to be designated, respectively, "**Class A Common Stock**," and "**Class B Common Stock**." The total number of shares of Class A Common Stock that this Corporation shall have authority to issue is 990 shares. The total number of shares of Class B Common Stock that this Corporation shall have authority to issue is 10 shares.

2. The amendment was adopted by unanimous vote of all of the shareholders and the sole director on December 28th, 2018.
