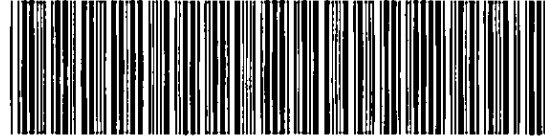

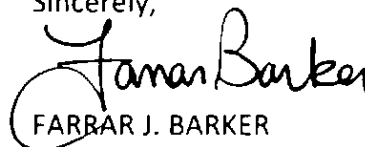

The undersigned incorporator, Dana Saffel, hereby presents these Articles of Incorporation as the Articles of Incorporation for PHARMACARE STRATEGIES, INC. pursuant to Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of the corporation is Pharmacare Strategies, Inc. This corporation is referred to in these Articles of Incorporation as the "Corporation."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing and street address of the principal office of the Corporation is 230 Sea Winds Drive, Santa Rosa Beach, Florida 32459.

ARTICLE III - PURPOSE AND POWERS

The Corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States. The Corporation shall have all powers that may now or hereafter be lawful for a corporation to exercise under the Florida Business Corporation Act.

ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue one hundred thousand (100,000) shares of common stock with \$10.00 par value per share.

**ARTICLE V - COMMENCEMENT OF CORPORATE EXISTENCE AND
TERM OF EXISTENCE**

The date for commencement of the Corporation's existence shall be the date these Articles of Incorporation are filed with the Florida Department of State. The Corporation shall have perpetual existence.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT
