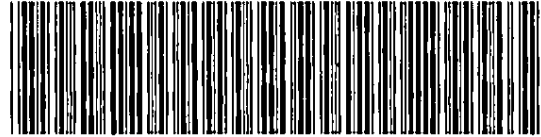

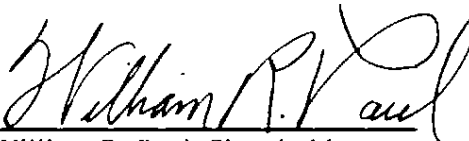

**ARTICLES OF INCORPORATION
OF
DAVID LOWRY, INC.**

These Articles of Incorporation of David Lowry, Inc. (*"these Articles"*) are filed with the Florida Department of State (*"the Department"*), having been adopted and approved by the sole director and sole shareholder of David Lowry, Inc. (*the "Corporation"*) in a written consent signed by such director and such shareholder, in order to domesticate the Corporation as a Florida corporation, having been initially formed as a California corporation on January 29, 1998. The aforesaid written consent was sufficient for such adoption and approval.

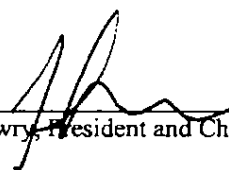
