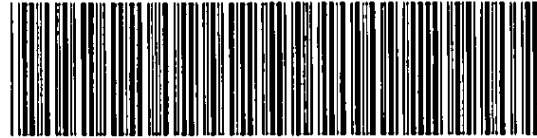



The corporation is authorized to issue 1,000 shares of no par value common stock.


