

ARTICLES OF AMENDMENT

Templeton Smaller Companies Growth Fund, Inc., a Maryland corporation having its principal office in Baltimore City, Maryland (hereinafter called the "Corporation"), certifies to the State Department of Assessments and Taxation of Maryland that:

FIRST: The Articles of Incorporation of the Corporation are hereby amended:

By amending Article SECOND to change the name of the Corporation to Templeton Global Smaller Companies Fund, Inc.

SECOND: The amendment to the Articles of Incorporation of the Corporation as hereinabove set forth shall be effective as of the 15th day of May, 1996.
