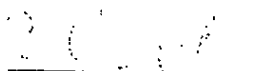
**ARTICLE V - AUTHORIZED SHARES**

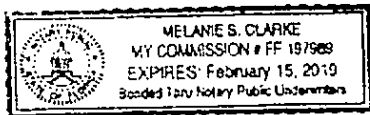
