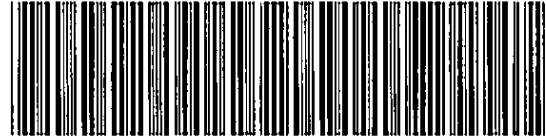

**ARTICLES OF INCORPORATION

In compliance with requirements of **F.S. Chapter 607**, the Undersigned, being a natural person, does hereby act as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I.

ARTICLE III.

The purpose for which the corporation is organized is: To manufacture, produce, purchase or otherwise acquire, sell, import, exports, distribute and deal in goods, wares, services, merchandise and materials of any kind and description. To engage in the construction, repair and remodeling of buildings and public works of all kinds, and for the improvement of real state, and the doing of any other business and contracting work incidental to or connected with such work, including demolition., produce repair, purchase or otherwise acquire, sell mechanical parts, electronic atmospheric wave manipulation for the betterment of the human race, space exploration and development

and development of equipment for such purpose, seismic exploration on earth and other celestial bodies of the known and unknown universe, not only limited to no geographical area within the jurisdiction of the United States and or any jurisdiction of friendly nations in this world The foregoing purposes and activities will be interpreted as examples only and not limitations, and nothing therein shall be deemed as prohibiting the corporation from engaging in any lawful act or activity for which a corporation may be organized under the General Corporation Law of the State of Florida.

The maximum number of shares this Corporation is authorized to issue is 5,000, all of which shall be common shares. The par value shall be .10 (10 Cents) per share. 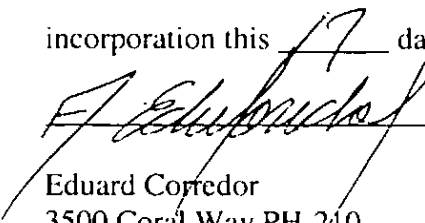

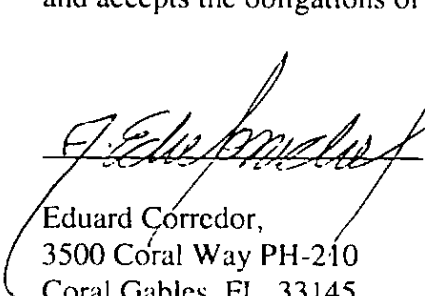
