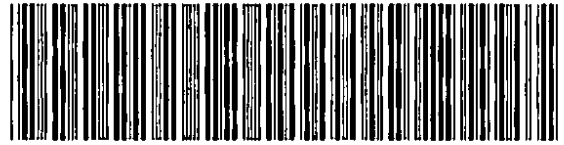



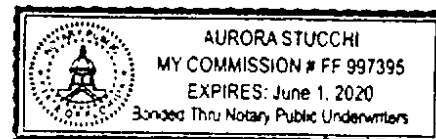
ARTICLE VII – Initial officer(s) and/or Director(s) of the corporation.
