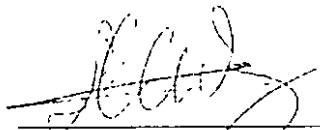

BEFORE ME, the undersigned authority, personally appeared Eilyn Socarras Hernandez, who after first being duly sworn, deposes and states as follows:

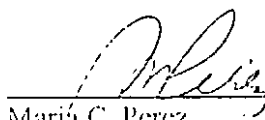
