The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name of the corporation (hereinafter called the "Corporation") is HEF-QUAIL ROOST V, INC.

SECOND: The street address and mailing address of the principal office of the corporation is 437 SW 4th Avenue, Ft. Lauderdale, FL 33315.

THIRD: The number of shares that the Corporation is authorized to issue is 10 shares of Common Stock, no par value.

FOURTH: The street address of the initial registered office of the Corporation in the State of Florida is 437 SW 4th Avenue, Ft. Lauderdale, FL 33315.


SIXTH: The purpose for which the Corporation is organized is as follows:
