The new name of the corporation shall be: **Diaz Buitron Inc.**



The only item for discussion was the change of name of the corporation from Krudo Fusion Cuisine Inc. to Diaz Buitron Inc.


All shareholders and Officers and Directors unanimously voted to change the name to the above name and continue the business under that name.


