**ARTICLES OF INCORPORATION  
OF

The undersigned incorporator, Don C. Keenan, hereby presents these Articles of Incorporation as the Articles of Incorporation for D.C. Keenan & Associates, P.A. pursuant to Chapter 607 and 621, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the corporation is D.C. Keenan & Associates, P.A. This corporation is referred to in these Articles of Incorporation as the "Corporation."

**ARTICLE II – PRINCIPAL OFFICE ADDRESS**

**ARTICLE III - PURPOSE AND POWERS**
