OF

The undersigned subscribers to these articles of incorporation hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I
NAME

The name of this corporation is REBECA CRUZ P.A.

ARTICLE II
GENERAL NATURE OF BUSINESS

The corporation, as principal or otherwise, is organized to buy, sell, exchange, import, lease, let, grant or take license in respect of, improve, develop, repair, maintain, manage or operate real and business property of every kind; and, generally, to do everything suitable, proper and conducive to the conduct of a real estate and asset holding company business in all of its branches and departments.

REGISTERED OFFICE AND REGISTERED AGENT


