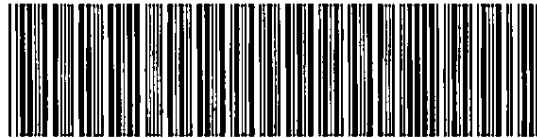

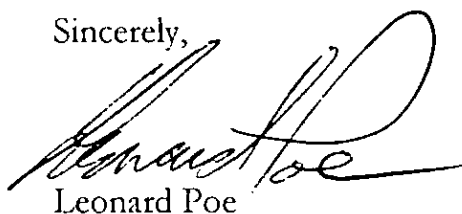

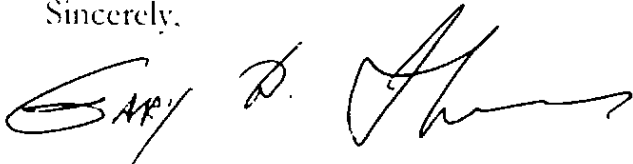

ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

BIOPLASTIC TECHNOLOGIES, INC.

Pursuant to sections 607.1006 and 607.0120 Florida Statutes, the undersigned, authorized President of the corporation submits these Articles of Amendment to Articles of Incorporation of BIOPLASTIC TECHNOLOGIES, INC.

1. The name of the corporation is BIOPLASTIC TECHNOLOGIES, INC.
2. Article IV of the Articles of Incorporation is hereby amended to read as follows:

Article IV

1. The number of common shares the corporation is authorized to issue is: 1,000.

Common shares shall be the only voting class of shares and shall have all rights and privileges as prescribed by law unless modified by a shareholders' agreement or by amendment to the Bylaws or Articles of Incorporation. All shares of stock issued and outstanding prior to the filing of this amendment shall be recharacterized as common shares upon the filing of this amendment.

2. The number of preferred shares the corporation is authorized to issue is: 100.

Preferred shares shall have the following limitations, rights, and privileges:

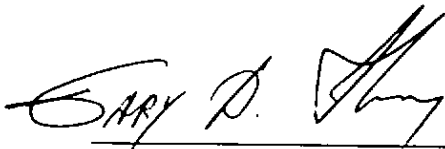
- A. Each preferred share is entitled to a 1% participation in any dividends declared for the common class, in any net liquidation proceeds upon dissolution, in any net proceeds from the sale of

substantially all of the assets of the corporation, or in any initial public offering of common stock.

- B. Preferred shares are personal to the shareholder to whom they are issued, and the corporation may redeem the preferred shares from the estate of any deceased preferred shareholder upon tender of the original consideration paid upon issuance. Preferred shares may not be transferred, voluntarily or involuntarily, to any other person or entity without prior approval of the corporation. Neither may preferred shares be pledged as collateral, nor shall the rights and privileges inure to the benefit of any creditor or to any bankruptcy trustee or receiver on behalf of any creditors through seizure, turnover, attachment, garnishment, or other legal process.
- C. Preferred shares may be issued by the Board of Directors for any specified consideration, which may vary for each such preferred share.
- D. Preferred shares shall not vote except as may be required by law.
- E. The form of the certificates representing preferred shares shall be prescribed in the Bylaws or by resolution of the Board of Directors.

- 3. A joint written unanimous resolution of the directors and shareholders approving this amendment was approved on December 3, 2019, and said resolution further authorized the President of the corporation to submit the amendment for filing with the Florida Department of State, Division of Corporations.
