ARTICLES OF INCORPORATIONOFAPTC, INC.

The undersigned, acting as the incorporator of the Corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such Corporation:

ARTICLE INAME OF THE CORPORATION

The name of this Corporation shall be **APTC, INC.**

ARTICLE IIPERIOD OF DURATION

The period of duration of the Corporation is perpetual.

PREEMPTIVE RIGHTS OF SHAREHOLDERS

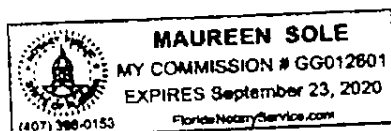


