The undersigned subscribers to these Articles of Incorporation, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is: META-FORA VENTURES, INC.

ARTICLE II. PURPOSE

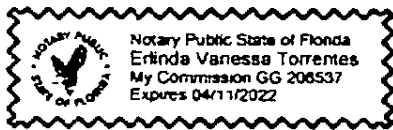


2. That your Affiants' attention has been called and affiant has inspected the seawall at the subject property which appears to have "settling" issues which is eroding the adjacent land.

5. That Affiant works for a licensed contracting firm and is a licensed contractor and has made personal inspection of the premises.

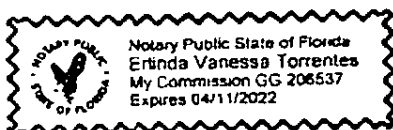
