# ARTICLES OF INCORPORATION OF

In compliance with the requirements of Florida Statutes Chapters 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a professional business corporation.

#### **ARTICLE I - NAME**

The name of this professional corporation is: Natasha Hunter, M.D., P.A.

#### ARTICLE II – PRINCIPAL OFFICE
