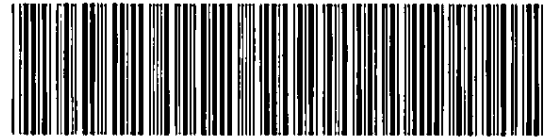

The Gvinge Equoni Waya Alahaya Tribal Trust must file the "CONSTRUCTIVE AND PUBLIC NOTE" of the creation, an establishment of GEWA BUSINESS INC. within 30 days of this notice.
