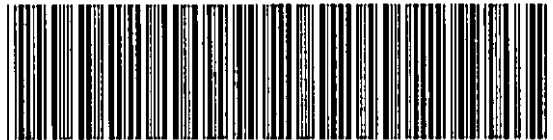

**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Sections 607.1003(7) and 607.1006 Florida Statutes, the corporation adopts the following amendments to its Articles of Incorporation:

- a) The name of the corporation is Workman Home Inspections, Inc.
- b) The text of each amendment adopted is as follows:


Article 5

CAPITAL STOCK
