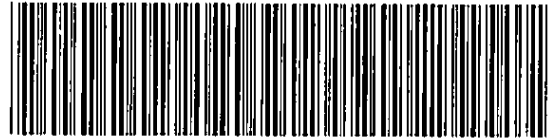

Good morning Diane

If you recall I called you to discuss the Revocation of Dissolution for our client;

Entity Name – Sierra Develoment & Construction Inc

EIN – 83-3545657

Document # - P19000011884

Per our conversation below is an explanation of what my client has been going through. As you mentioned, please review it with your manager to see if there is anything that can be done regarding the matter. They will be facing contractual issues with their client if we cannot get the Articles of Revocation of Dissolution processed accordingly.

1. On January 12th of 2023, the Articles of Dissolution was processed by Mima Irma Sierra.
2. On April 13th of 2023, Mima received the opportunity to take on a new contract that prompted her to revoke the dissolution, therefore she came to our office and requested assistance in getting the entity back to an active status. We assisted her in preparing the Articles of Revocation and sent them to Division of Corporations via certified mail. The tracking number given to us by USPS was 7020 3160 0001 6061 2476.
3. On May 24th of 2023, we noticed that the entity was still not active on Sunbiz.org and we contacted the Division of Corporation to verify what was going on. We were told that the division had not received the correspondence and we offered to fax a copy of the articles and check that was mailed to the Division. The fax was successfully transmitted at 12:53 EDT and we received confirmation of receipt. A copy of the document is also attached to this email.
4. On May 25th of 2023, we communicated with USPS to see what occurred with the correspondence. They requested that we wait until 05/31/2023 for a response via email, otherwise contact them again and request a letter of explanation. Service request # 51386003 was given to us.
5. On May 31st of 2023, we received an email from USPS regarding service request # 51386003 (attached in this email as well), stating that the tracking number was not valid. We immediately contacted USPS to dispute this. They notified us over the phone unfortunately there are instances where the staff members fail to scan in packages/correspondence and that they get lost as a result of the mistake, and that this was what occurred more than likely.
6. On June 1st of 2023, my office manager, Julissa Amaral, reached out and forwarded to you the response we got from USPS and you responded stating that the 120 days had passed and there was not much you could do. But it seems like the Division of Corporation had already deposited the \$35.00 fee for the revocation (for the record, this was later refunded).

Fast forward to today, the issue is still unresolved. Mima has reached out to me concerned because since the day we mailed her Articles of Revocation of Dissolution her business has been operating with the expectation that the Division would have reinstated the entity. But since it was not reinstated she has been facing multiple issues such as her insurance company threatening to cancel her insurance coverage and a client that is unwilling to pay her due to the status of the entity on sunbiz.org.

The toughest part of it all, is that she relied on us to mail the articles in a timely manner, which we did, however because USPS failed to properly register the correspondence within their system, it seems it was lost. While I am unequivocally confident that we did mail out the revocation in a timely manner, I am left with no more recourse than providing you with all of the data mentioned in this email, which clearly shows our engagement in getting this resolved for the client, so I can tell you with confidence that we have been doing our part and have attempted since April of this year to resolve the matter for the client. But due to the mistake and negligence of an USPS employee, the issue is knocking at my door and my poor client is now facing the risk of losing her coverage, future contracts, and is having a hard time collecting from a client for work that has already been completed and employees have been paid.

I am asking for you and your team to review this closely and see if you can take into consideration the fact that we have recorded every step of the way and have diligently tried to resolve the issue on the client's behalf. I am not sure what else I can do at this point, but I cannot fail my client and need to find a solution. Please see what you can do to help me get this issue resolved.

Thank you in advance for taking your time to help. If you need anything else from me let me know as this is of high importance.
