*The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

**ARTICLE I: NAME**

The name of the corporation shall be: **TOOLS BY DESIGN, INC.**

**ARTICLE III: EXISTENCE AND DURATION**

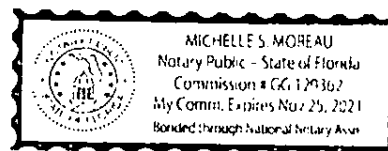


