ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby concur to form a corporation under the laws of the State of Florida, Chapter 607, Florida Statutes and certify as follows:

ARTICLE I

The name of the corporation shall be **FERRADAS FAMILY FARM INC.**, for convenience the corporation shall be referred to in this instrument as the corporation. The principal place of business of this corporation shall be 13800 SW 224th Street, Miami, FL 33170.

ARTICLE II

The nature of business of this corporation is to engage in or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation.


