TO
ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned professional corporation adopts the following amendment to its Articles of Incorporation:

1. The name of the corporation is CareSpan MedPsych Network, P.A. (the “**Corporation**”).
2. The following amendment to the Articles of Incorporation of the Corporation was adopted by the sole shareholder (the number of votes cast being sufficient for approval) and the Board of Directors of the Corporation by the Action by Joint Written Consent of the Shareholder and Board of Directors in Lieu of a Special Meeting dated January 31, 2021 in the manner prescribed by Sections 607.1003 and 607.1006 of the Florida Business Corporation Act:
