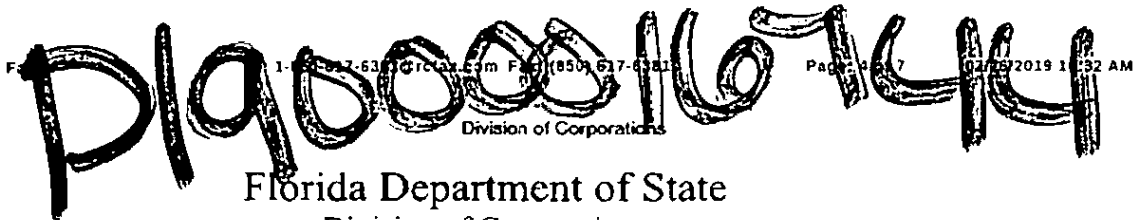

The name and street address of the incorporator are Courtney Sipes, 2593 1st Avenue #B, Fernandina Beach, Florida 32034.


ARTICLE X - BYLAWS


