

# ARTICLES OF INCORPORATION OF TARAY HOLDINGS, INC.

The undersigned, acting as incorporator of Taray Holdings, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

## ARTICLE I. NAME

The name of the corporation is Taray Holdings, Inc.

## ARTICLE II. ADDRESS

## ARTICLE III. COMMENCEMENT OF EXISTENCE

#### ARTICLE V. AUTHORIZED SHARES
