whose mailing addresses shall be the same as the mailing address of the Corporation.



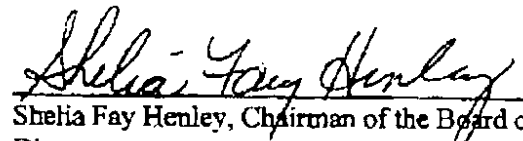
