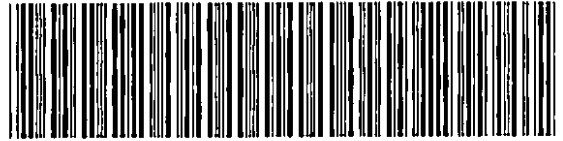

Pursuant to the provisions of Section 607.1005 of the Florida Business Corporation Act, Purcheck Management, Inc., a Florida corporation (the "Corporation") adopts the following Amendment (the "Amendment") to the Articles of Incorporation (the "Articles of Incorporation") of the Corporation:

1. The Articles of Incorporation were filed with the Secretary of State of the State of Florida on March 12, 2019 and assigned Florida document number P19000020825.

2. The name of the Corporation in the Articles of Organization as filed contained a typographical error, and as of the Effective Date (as defined below) no shares of stock have been issued by the Corporation.

3. Accordingly, Article I of the Articles of Incorporation shall be amended to read as follows:

The name of the corporation is:



THE UNDERSIGNED, being the sole incorporator of Purcheck Management, Inc., a Florida corporation (the "Corporation"), hereby certifies the following:


