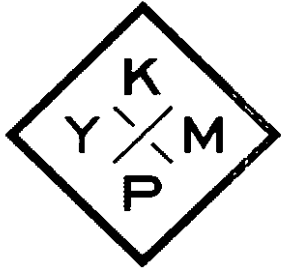

Several weeks ago, I registered a corporation named Dynamic Puppy, LLC. This was done in error as I needed the entity to be a standard corporation. I then registered the same entity as a corporation with an "Inc." suffix.

A week after that registration, I received notification that my new filing was rejected because it was too similar to the LLC I had inadvertently filed. I then dissolved the LLC and changed the name of the entity to "The Dynamic Puppy, Inc."

I have now received another bounce back stating the names are still too similar and I must wait 120 days after the LLC is dissolved to use the name.
