# ARTICLES OF INCORPORATION

OF

### FORCE Customs, Inc.

The undersigned, acting as the incorporator of FORCE Customs, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

### ARTICLE I. NAME
