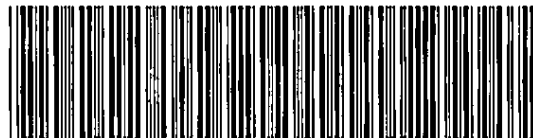



**ARTICLES OF INCORPORATION
OF
RESOURCEFUL HOUSING, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the Corporation is: Resourceful Housing, Inc..

ARTICLE II – PRINCIPAL OFFICE

The street address of the principal office of the Corporation is: 9222 Brindlewood Drive, Odessa, FL 33556.

ARTICLE III – PURPOSE

The purpose for which the corporation is organized is for any lawful purpose or purposes.

ARTICLE IV – SHARES

The maximum number of shares this Corporation is authorized to issue is 1000, par value \$ 1.00 per share, all of which shall be Common Shares. 


