ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
JD LAB, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, pursuant to a consent meeting of all the Shareholders and members of the Board of Directors effective April 23, 2019.

1. The date of filing the Articles of Incorporation was March 27, 2019, and Florida Document Number P19000026430 was assigned to such filing.

2. Article IV is deleted in its entirety and the following is substituted in lieu thereof:

"ARTICLE IV.

The aggregate number of shares which this Corporation is authorized to issue is 200,000 shares of common stock. Each share shall have a par value of \$.01.

Said stock shall be issued for such consideration having a value not less than the par value of the shares issued therefor as is determined from time to time by the Board of Directors; however, neither promissory notes nor future services shall constitute payment or part payment for the issuance of shares of stock of this Corporation."

3. In all other respects, except as specifically changed and modified in these Articles of Amendment to the Articles of Incorporation, all of the provisions contained in the Articles of Incorporation shall be and remain the same.
