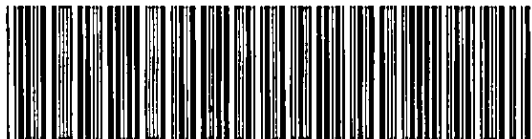

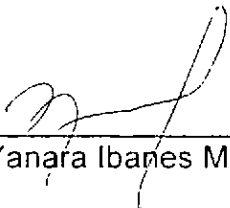
## ARTICLE VIII - BEGINNING OF CORPORATE EXISTENCE
